The members of the Chairs Council appreciate the impact of enrollment on the financial well-being of the university. The council understands that support from the department chairs is an important element in the recruitment and retention process. The Council believes that academic departments are the most critical factors in insuring the quality of MTSU academic programs. The Council also believes that the quality of academic programs and the quality of graduates is of the utmost importance in maintaining a positive reputation and a sustainable future for the university. Importantly, maintaining high quality academic programs necessitates that students who are admitted to the university are prepared for academic challenges inherent to those programs.

The Chairs Council has examined ACT scores and high school grade point averages (HSGPA) as they relate to student success at MTSU. Specifically, the Council examined the 6 year graduation rate relative to ACT and HSGPA. We also examined success in general education classes relative to ACT and HSGPA. The analysis indicates that a shift in our admissions policy is needed. Students who are admitted to the university with an ACT score below 19 have a DFW rate in the general education courses of 36.4 % versus 23.6% for students who have an ACT of 19 or higher. Students who have an ACT lower than 19 have a 6 year graduation rate of 34.78% versus 47.97% for students with an ACT of 19 or higher. (all data are obtained from IEPR and are attached)

The Chairs Council has examined HSGPA relative to student success. The current admissions standards allow students who have a HSGPA of 3.0 or higher to have unconditional admission. However, the data show that students with a HSGPA between 3.0 and 3.5 actually have a lower success rate in general education courses and a lower graduation rate than the aggregate (see attached data regarding success rates in Gen Ed courses). Students with a HSGPA of 3.5 or higher have a 6 year graduation rate of 63.71% versus 34.72% for students with a HSGPA lower than 3.5. This data suggest that 3.5 would be a better cut off for unconditional admission than 3.0.

Accordingly, the Chairs Council strongly recommends that recruiting of students should be focused on higher ability students. The recruitment of higher ability students

will result in the admission of students with higher retention and graduation rates. This strategy will benefit MTSU in terms of the Tennessee funding formula for higher education institutions. The Chairs Council recommends that the Provost and the Vice President for Student Affairs organize a campus-wide initiative aimed at increasing the guaranteed HSGPA admission standard from 3.0 to 3.5. The council realizes that this will require significant discussion and planning and will be a multi-year process.

The resulting change in admissions will be from the current guaranteed admissions requirements:

3.0 GPA, OR

Minimum composite ACT score of 22 (Equivalent SAT of 1020-Critical Reading & Math), OR

Minimum 2.7 GPA plus ACT score of 19 (Equivalent SAT of 900- Critical Reading & Math)

to:

3.5 GPA, OR
Minimum composite ACT score of 22 (Equivalent SAT of 1020-Critical Reading & Math), OR
Minimum 2.7 GPA plus ACT score of 19 (Equivalent SAT of 900- Critical Reading & Math)

The Chairs Council requests that this recommendation be reviewed and discussed by both Academic Affairs and Student Affairs and that a response to our recommendation be given to the council. The Council is eager to work cooperatively with the Provost and the Division of Student Affairs on this initiative to enhance student success at MTSU.
